## **ATTENTION EXHIBITORS 2026**

The Show Giving Clubs will not be responsible for the loss of or damage to any dog exhibited, or for possessions of any exhibitor, whether the result of an accident or any other cause. It is distinctly understood that every dog at this show is in the care and custody of his owner or handler during the entire time the dog is in the show building or the grounds at Tri-County Dog Training. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of the show.

Transfers will be allowed in accordance with Chapter 1, Section 16a & b of the American Kennel Club Rules and Regulations.

All Dogs present must be held on leash or confined to their crates except when being judged or when exercising.

There will be no space provided for unentered dogs at this show. No open top pens or crates in building.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$4.00 will be required for each recordable single-entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). An AKC Recording Fee of \$4.50 1st Entry & \$4.00 additional entry of same dog will be required for each entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 3) These Fees are paid to the American Kennel Club. ( This fee is included in your entry fee)

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

There will be no refund for duplicate entries.

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs allowed in rings during judging only.

Dogs must be ready for judging. Neither the club nor its Trial Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of the Show Committee.

Females in season are not permitted to compete. The Event Secretary must be notified no later than one half hour prior to the start of the trial with documentation from exhibitors veterinarian. Entry fee will be refunded less a \$10.00 processing fee per entry.

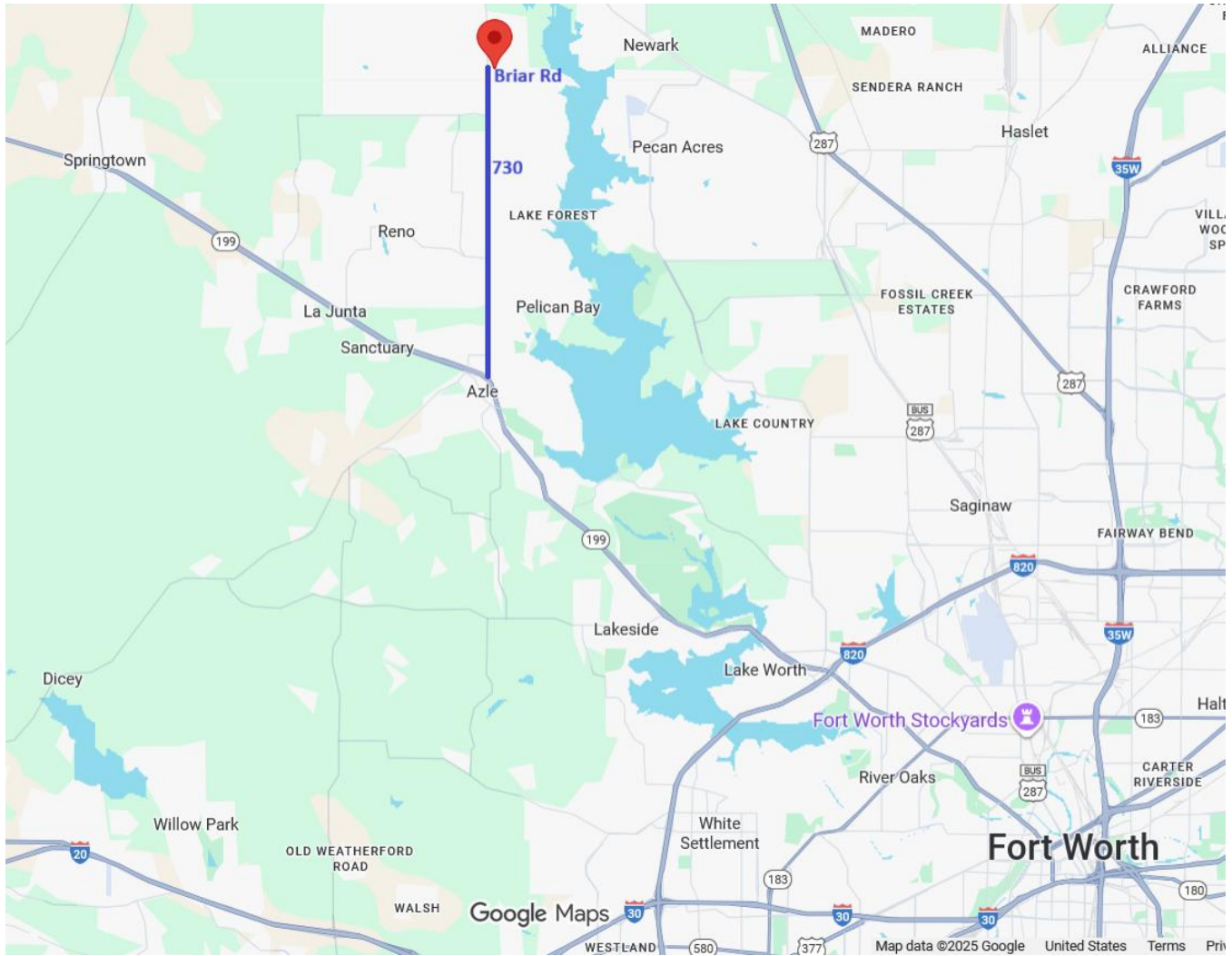
Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Trial Secretary.

The clubs assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form.

Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.
